Budget Reconciliation

- House-passed package: One Big Beautiful Bill Act (H.R.1)
 - 45Q largely preserved
 - Transferability phase-out; 2 years after enactment
 - Foreign Entity of Concern Restrictions:
 - Restricts access to the credit for certain prohibited foreign entities:
 - No credit is allowed for taxable years beginning after enactment if the taxpayer is a specified foreign entity.
 - No credit is allowed for tax years that begin two years after date of enactment for a foreign-influenced entity.
 - Removed:
 - Federal permitting pathway for CO2 pipelines
 - \$60M in rescissions at OCED
