# ABOUT US

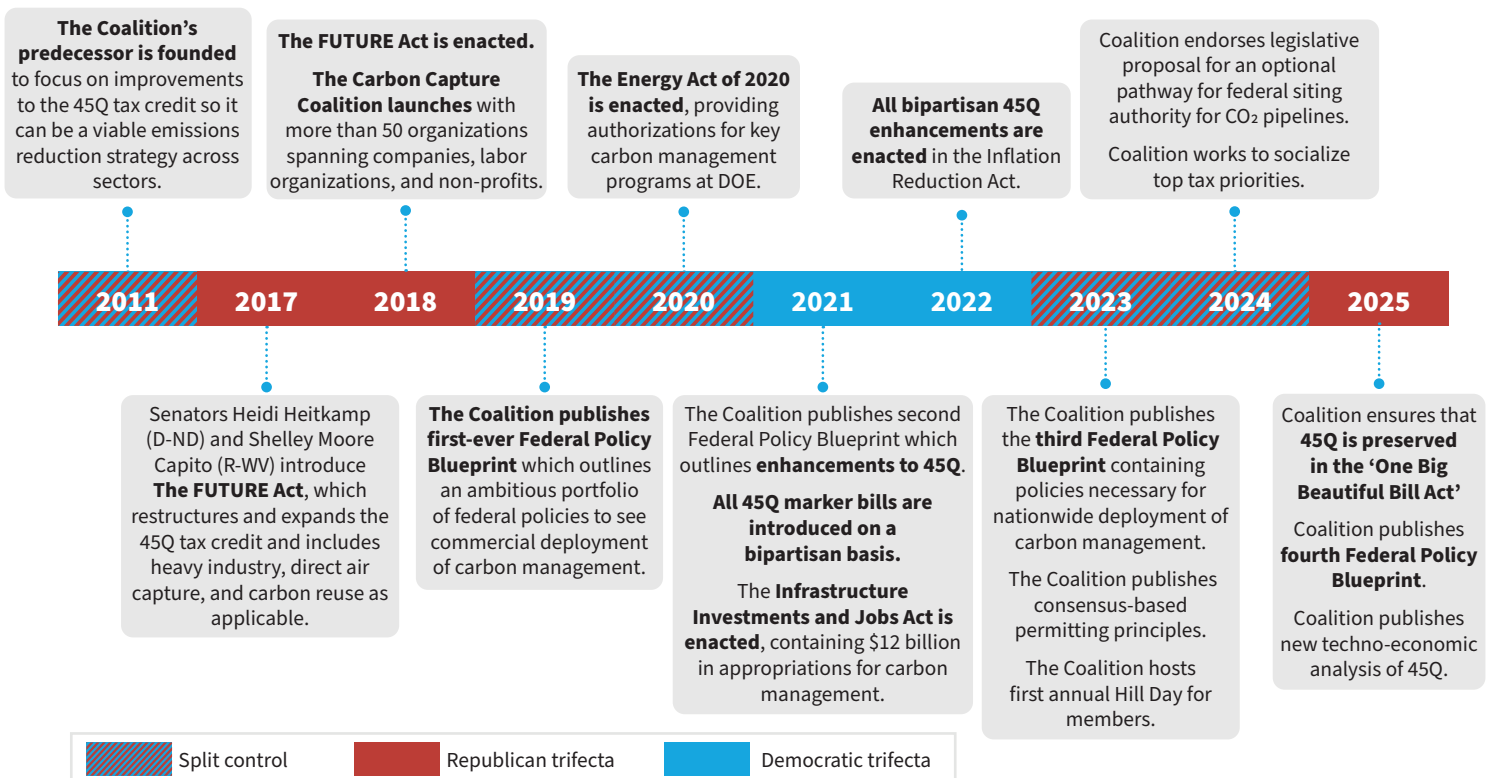
The Carbon Capture Coalition is a nonpartisan collaboration comprising companies, labor unions, and environmental policy organizations.

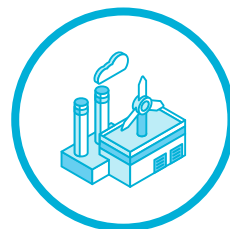
## Advocate for Durable Policy Alongside Peer Organizations

Beginning in 2026, the Coalition's allied 501(c)(4) partner, Carbon Capture Impact, will build on the Coalition's deep ties to policymakers and federal agencies and take carbon management advocacy to the next level. While the Coalition identifies a range of consensus-based policy solutions in the [Federal Policy Blueprint](#), Impact will focus on near-term opportunities to adopt and implement policies. Impact staff facilitates members' understanding of the complex political issues at play for carbon management policy and provides its members opportunities for direct engagement with policymakers on shared priorities. Impact welcomes participation from members in advocacy meetings including Impact's annual Capitol Hill Day.



## Participation in Member Events

The Coalition regularly hosts events to which Coalition members are invited to attend. These include Coalition Working Group meetings, media briefings with reporters from national outlets and trade press, educational webinars, and our flagship event, the Coalition's Annual Meeting.



## Tap into a Broader Carbon Management Network

While the Coalition and Impact are exclusively focused on building support for the necessary portfolio of federal policies for carbon management, we are part of a broader network of experts at the Great Plains Institute's [Industrial Innovation and Carbon Management](#) team. This team of experts regularly engages with stakeholders and constituencies at the community, regional, and state levels on industrial decarbonization, innovation, and carbon management, and is an available network for Coalition and Impact members.



## KEEPING COALITION MEMBERS INFORMED

In addition to these core activities, Coalition members receive several benefits that help them **stay current on policy development and regulatory, technical, and communications topics** across the carbon management supply chain.

→ **Timely Information on Key Federal Policy Developments:** Coalition members receive our weekly Update Newsletter, which wraps up key topics across the federal government and other news in the carbon management space. Additionally, this newsletter updates our membership on recent Coalition activities, including Work Groups, staff activities, and more. Our Work Groups also receive regular updates on pertinent topics.

→ **Coalition Branded Materials to Advance Our Shared Priorities:** We arm members for their work in carbon management through relevant fact sheets, press releases, analyses, and other materials on timely, pertinent issues in the carbon management space. You can see our publicly available resources on our website. Members also receive access to talking points, email templates, and more, to help aid in their work in communicating about needed federal policies to enable the nationwide deployment of the carbon management value chain.

→ **Access to the Coalition's Member Web Portal:** The Coalition provides all our members with a secure website with a central location to access all materials, including Coalition work products, talking points, Work Group call notes, and other relevant information to help keep you informed.

# HOW WE WORK

While the Coalition's day-to-day work is staffed by Coalition staff and consultants, Coalition members meaningfully engage in its work through standing work groups, representing the Coalition to members of the media and stakeholders, and may participate in advocacy opportunities through our allied 501(c)(4) organization, Carbon Capture Impact. The Coalition operates on a consensus model, where members can propose issues and ideas and provide feedback on Coalition priorities to ensure that we can remain effective advocates for the adoption and deployment of this suite of essential technologies.

Members of the Coalition collaborate to envision and develop the comprehensive portfolio of bipartisan policies necessary to commercialize a domestic carbon management sector.
